



Referral Program Terms and Conditions

Wingly is the commercial name of the platform operated by Berlaric SAS (hereinafter “Berlaric”).

For the purposes of these Referral Terms and Conditions, “Wingly” shall refer interchangeably to the platform operated by Berlaric and, where applicable, to Berlaric itself.

Wingly offers a pilot referral program (the “Referral Program”), governed by these provisions (the “Referral Terms and Conditions”).

Any pilot participating in the Referral Program shall be deemed to have accepted these Referral Terms and Conditions as well as Wingly’s General Terms of Service.

Wingly reserves the right to exclude any user who does not comply with the rules of the Program.

For the purposes of the Program:

- the “Referrer” means a Wingly pilot who invites another pilot
- the “Referee” means a pilot invited to join Wingly
- the “Eligible Flight” means a flight completed on Wingly with a minimum

booking request value of €140 (or equivalent in local currency) and a minimum flight duration of 45 minutes, effectively carried out, not cancelled, and subject to a valid and uncontested payment

1. Eligibility Conditions

Referrer

- Must be a pilot with a Wingly pilot account
- Must hold a valid pilot license (LAPL, PPL or CPL) and a valid medical certificate (at least LAPL medical), both approved on their Wingly account

Referee

- Must be an individual pilot
- Must not have an existing or previously created pilot account on Wingly
- Must create an account via the referral link
- Must hold a valid pilot license (LAPL, PPL or CPL) and a valid medical certificate (at least LAPL medical), both approved on their Wingly account

Wingly reserves the right to reject any referral that does not meet these conditions.

2. How It Works

The Referral Program operates as follows:

- The Referrer logs into their Wingly account and generates a unique referral link (the “Referral Link”)
- The Referrer shares this link with another pilot
- The Referee signs up to Wingly using this link
- The Referee completes their pilot profile and submits the required documents
- Wingly verifies the Referee’s pilot license (LAPL, PPL or CPL) and medical certificate (at least LAPL medical)
- The Referee publishes and completes their first Eligible Flight on Wingly

3. Rewards

Subject to compliance with all conditions set out in these Referral Terms and Conditions:

- The Referee receives a €20 reward, paid after completing their first Eligible Flight on Wingly and subject to validation by Wingly
- The Referrer receives a €70 reward, paid after the Referee completes their first Eligible Flight and subject to validation by Wingly

Rewards:

- are personal
- are non-transferable and cannot be exchanged
- are subject to payment terms defined by Wingly (e.g. bank transfer)
- are subject to the provision of a valid IBAN and successful completion of any required identity and KYC (Know Your Customer) verification processes by Wingly and/or Mangopay (the payment provider service used by Wingly)

Wingly reserves the right to cancel or refuse any reward in case of fraud or abuse. Wingly reserves the right to withhold or delay payment of any reward in case of ongoing verification, suspected fraud, or dispute related to the Eligible Flight.

4. Referral Validation Conditions

A referral is considered valid only if:

- Both the Referrer and the Referee hold valid pilot license (LAPL, PPL or CPL) and a valid medical certificate (at least LAPL medical), both approved on their Wingly account
- The Referee registered via the Referrer’s referral link
- The Referee has completed a first Eligible Flight that was effectively carried out, not cancelled, and subject to a valid and uncontested payment

- The time between the referral and the Referee's first Eligible Flight is less than one year
- The applicable reward conditions (including reward amounts and eligibility criteria) are those in effect at the time the Referral Link is generated and shared by the Referrer, and shall remain applicable to the corresponding referral, regardless of any subsequent changes to the Program.

5. Restrictions

- The Program is intended for personal and non-commercial use only
- The referral link must not be shared on public platforms (such as coupon sites, forums, etc.), under penalty of reward cancellation
- The Referrer and the Referee cannot be the same person, belong to the same household, or act in concert to circumvent the Program
- Wingly reserves the right to request proof regarding how the referral link was shared
- A Referee may only be referred once
- A Referrer may not exceed 20 successful referrals per calendar year

Any fraudulent behavior (creation of fake accounts, self-referral, etc.) will result in:

- cancellation of rewards
- and may lead to account suspension
- Wingly reserves the right to disregard any flight deemed artificially structured or manipulated to meet the Eligible Flight conditions.

6. Changes and Duration

Wingly reserves the right to:

- modify the terms of the Program at any time
- suspend or terminate the Program without prior notice

No compensation shall be due in this respect.
